
#### **Education and Early Years T Level (Level 3)**

## Year 1 (Core):

#### <u>Industry Placement (year 1 and year 2):</u>

#### Safeguarding

#### Task 1

If you work in the early years sector, it is important you comply with safeguarding measures to ensure the wellbeing of all the children at your setting. As you will be on an industry placement it is essential that you understand safeguarding and what your responsibilities are.

- 5. An important component of safeguarding children is promoting good health and wellbeing. High standards of hygiene and cleanliness help prevent the spread of infections and illnesses in a setting. Identify three things early years education providers must do to promote health and wellbeing.
- 6. Anybody who works with children must have a Disclosure and Barring Service (DBS) check. You will have a DBS check before you start your industry placements. Explain what a DBS check is and why it is important.

#### **Equality and Inclusive Practice**

Equality means recognising and responding fairly to the individual needs and identities of everyone. Inclusive practice means to provide everyone with an opportunity to reach their full potential and have an equal chance to live their life as they choose. Equality also refers to the way we handle cases of prejudice and discrimination to ensure that everyone is treated fairly and that prejudice and discrimination is challenged. On your industry

placement you must ensure you treat all the children and adults you will be working with, with respect. It is your responsibility to contribute to equality and inclusive practice.

- Ensure children can see themselves and their families in the environment
- Focus on the child at the centre

- Practitioners working with children with Special Educational Needs and Disabilities (SEND) acknowledge and value each child, emphasising what they can do through a strengths-based perspective on disability.
- Developing a sense of belonging is an important part of inclusive practice
