

CHARGING AND REMISSIONS POLICY

1. Admissions

- 1.1 There is no charge for admissions.

2. School meals

- 2.1 There is no charge for pupils who are entitled to free School meals or infant free School meals. Pupils who are not entitled to free School meals will be charged. Charges are set by each School based on the catering provider's costs.

3. Public examinations

- 3.1 There is no charge for examinations that are part of the curriculum and on the School's set examinations list, where pupils have been prepared for the examinations by the School. However, if the pupil fails without good reason to meet an examination requirement, the School may recover the fee incurred from that pupil's parent/guardian. These principles apply equally to re-sits.
- 3.2 There is no charge for examinations that are not on the set list but have been arranged by the School.
- 3.3 There is a charge of the examination entry fee(s) if the registered pupil has not been prepared for the examination(s) at the School (see Optional extras under section 5)

4. Activities that take place during School hours (this does not include the break in the middle of the School day)

- 4.1 There is no charge for activities during School hours except for music tuition (section 8).
- 4.2 There is no charge for transport during School hours to School-organised activities. Schools may ask for voluntary contributions to cover the cost of such transport; if transport costs cannot be covered trips may not run and Schools reserve the right to withdraw trips if this is the case.
- 4.3 We may charge for:
- a) materials, books, instruments or equipment that the parent/guardian wishes their child to keep or own (the cost will be made clear before charge)
 - b) optional extras (section 5)
 - c) music or vocal tuition (section 8).

5. Activities that take place outside of School hours (non-residential)

- 5.1 There is no charge for activities that take place outside of School hours when they are:
- a) part of the set curriculum
 - b) part of the syllabus for a public examination that the pupil is being prepared for by the School
 - c) part of the School's basic curriculum for religious education.

Optional extras

- 5.2 The School will charge for optional extras. Optional extras are:
- a) education provided outside of School time that is not:
 - i. part of the National Curriculum
 - ii. part of a syllabus for a prescribed public examination that the pupil is being prepared for at the School
 - iii. part of religious education
 - b) examination entry fee(s) if the registered pupil has not been prepared for the examination(s) at the School
 - c) transport that is not taking the pupil to School or to other premises where the School has arranged for the pupil to be provided with education.
 - d) board and lodging for a pupil on a residential visit.
 - e) extended day services offered to pupils (e.g. breakfast clubs, after School clubs etc)

The cost of optional extras

- 5.3 Schools will decide locally when it is necessary to charge for optional activities, and will set out the charges.
- 5.4 Any charge made in respect of individual pupils will not exceed the actual cost of providing the optional extra activity, divided equally by the number of pupils participating. In no circumstances will there be an element of subsidy required for any pupils wishing to participate in the activity whose parents/guardians are unwilling or unable to pay the full charge (section 12).
- 5.5 When calculating the cost of optional extras an amount may be included in relation to:
- a) any materials, books, instruments or equipment provided in connection with the optional extra
 - b) non-teaching staff
 - c) teaching staff engaged under contracts for services purely to provide an optional extra, including supply teachers engaged specifically to provide the optional extra
 - d) the cost, or a proportion of the costs, for teaching staff employed to provide tuition in playing a musical instrument, where the tuition is an optional extra.
 - e) The costs of buildings and accommodation.
- 5.6 Participation in any optional extra activity will be based on parent/guardian choice and a willingness to pay the charges. The School will need to have the agreement of parents/guardians before organising the provision of an optional extra where charges will be made.

6. Activities that take place partly during School hours either on or off site

- 6.1 Where most of a non-residential activity takes place during School hours the charging of the activity will be the same as is outlined in section 4.

- 6.2 Travelling time is included in time spent on the activity if the travel itself occurs during School hours.
- 6.3 In cases where most of a non-residential activity takes place outside of School hours the charge cannot include the cost of alternative provision for those pupils who do not wish to participate. So, no charge can be made for supply teachers to cover for those teachers who are absent from School accompanying pupils on a visit.
- 6.4 In this case the charging of the activity will be the same as is outlined in section 5.

7. Residential activities

- 7.1 The School will not charge for:
- a) education provided on any visit that takes place during School hours
 - b) education provided on any visit that takes place outside School hours if it is part of the National Curriculum, or part of a syllabus for a prescribed public examination that the pupil is being prepared for at the School, or part of religious education
 - c) supply teachers to cover for those teachers who are absent from School accompanying pupils on a residential visit
 - d) travel costs where the residential activity is classed as being within School hours
 - e) residential activities that take place during School hours.

- 7.2 The School will charge for:

Board and lodging

- 7.3 When any visit has been organised by the School where there may be a cost for board and lodging, parents/guardians will be informed of this before the visit takes place. We will charge anything up to the full cost of board and lodging on residential visits, whether it is classified as taking place during School hours or not. The charge will not exceed the actual cost. Parents/Guardians who can prove they are in receipt of certain benefits may be exempt from paying the full cost (see section 11 for more guidance on remissions).

Travel

- 7.4 Travel charges may apply when the residential activity takes place outside of School hours. The amount charged will be calculated to cover the unit cost per pupil. These charges may not apply to those pupils entitled to remissions, but no other pupils will be charged extra to cover those costs.

Activities

- 7.5 The School may charge for residential activities that fall outside of School hours (see section 5).

8. Music tuition within School hours

- 8.1 The School follows government legislation that states that all education provided during School hours must be free; however, music lessons are an exception to this rule.
- 8.2 Charges may be made if the teaching is not an essential part of either the National Curriculum or a public examination syllabus being followed by the pupil(s).

- 8.3 The School may charge for teaching requested by parents/guardians and delivered by specialist tutors given to either an individual pupil or groups of any appropriate size (provided that the size of the group is based on sound pedagogical principles) to play a musical instrument or to sing. The cost of these lessons may depend on the size and duration of the class as well as the type of instrument.
- 8.4 The School will not charge if the music tuition is part of the National Curriculum or public examination syllabus being followed by the pupil. This includes instruments, music books and exam fees.
- 8.5 There is no charge for vocal or instrumental tuition for a pupil who is looked after by a local authority. This includes instruments, music books and exam fees.

9. Extended services

- 9.1 The School provides a well-rounded and extensive education for pupils which includes a wide range of extra-curricular activities (extended services). Extended services may include:
- a) high-quality learning opportunities either side of the School day
 - b) ways of intervening early when pupils are at risk of poor outcomes, e.g. by providing access to study support, parenting support or to more specialist services (such as health, social care or special educational needs services)
 - c) ways of increasing pupil engagement
 - d) ways of improving outcomes and narrowing gaps in outcomes between different groups of pupils.
 - e) Breakfast and after School clubs. Charges cover the additional costs of staff, materials and refreshments used during the club.
- 9.2 The total charge will not exceed the cost of providing the activity and no parent/guardian will be asked to subsidise others.

10. Home to School Transport

- 10.1 There is no requirement for the School or Trust to provide transport between home and School. Where a home to School transport service is offered, options and charges will be determined annually with booking options provided before the start of the academic year. The School or Trust reserve the right to amend or withdraw the service if there is insufficient demand.

11. Refunds

- 11.1 Requests for refunds for trips will be considered on an individual basis and may be rejected if the School is unable to recoup the costs incurred.
- 11.2 In all cases of withdrawal, either voluntarily or otherwise, applications should be made in writing to the Headteacher. If approved, refunds will be processed via the original method of payment.
- 11.3 The School reserves the right not to refund costs where a pupil is withdrawn from an activity by the School because of a pupil's breach of the School's behaviour policy.

12. Damage to property and breakages

- 12.1 Where School property has been willfully or recklessly damaged by a pupil or parent/guardian the

School may charge those responsible for some or all the cost of repair or replacement.

- 12.2 Where property belonging to a third party has been damaged by a pupil, and the School has been charged, the School may charge some or all the cost to those responsible.
- 12.3 Whether or not these charges will be made will be decided by the Headteacher and dependent on the situation.

13. Remissions and concessions

- 13.1 The School will consider the remission of charges to parents/guardians for whose pupils the School receives Pupil Premium funding. The School receives Pupil Premium if parents/guardians have successfully applied for Free Schools Meals. Parents/ guardians should contact the School if they need advice on applying for Free School Meals.
- 13.2 Parents/guardians who are eligible for the remission of charges will be dealt with confidentially. The Headteacher will authorise the remission of charges.
- 13.3 The School may choose to subsidise part or all of the payment of some charges for certain activities and pupils, and this will be determined by the Headteacher.

14. Voluntary contributions

- 14.1 The School may ask for voluntary contributions to the School for general funds and/or to fund activities that will enrich our pupils' education.
- 14.2 In any case where an activity cannot be afforded without voluntary funding, this will be made clear to the parents/guardians by the School. If the activity is cancelled all monies paid will be returned to parents/guardians.
- 14.3 There is no obligation for a parent/guardian to make any contribution and the School will in no way pressure parents/guardians to contribute.

15. Inability or unwillingness to pay

- 15.1 The School is committed to ensuring fair access and treatment of all pupils, and this means ensuring that no child is excluded from an activity because the parents/guardians of that child are unwilling or unable to pay. If there is insufficient funding for an activity, then it will be cancelled.
- 15.2 The identity of the child or parents/guardians of the child who did not want to make the payment, or could not make the payment, will not be disclosed under any circumstances.

16. Complaints

- 16.1 Complaints about the implementation of this policy or any decisions taken in line with the policy will be considered as part of the School's complaints procedures.
